Please read carefully. All rules must be followed.

- 1. This is a Juried Craft Show for handcrafted/ homemade items only.
- 2. Crafter space is outdoor only and non-refundable. Rain or Shine! Absolutely no refunds for any reason after August 1<sup>st</sup>. In the event that the venue must cancel, full refunds will be issued. **SAVE \$25 by applying before April 30th! Before 4/30: 10'x10' space=\$50, 10'x20'=\$100**. After 4/30: 10'x10'=\$75, 10'x20'=\$140.
- **3.** You will receive a confirmation email when your application is received. The first jury meeting will tentatively be on April 30<sup>th</sup>.
- 4. A photo (via mail or email), along with signed application and booth fee must be received in order for your application to be juried by the board. No photo necessary if you are a returning crafter from 2024.
- 5. Spaces are on a first come basis. We will only be accepting a limited number of types of crafts per winery to provide a good balance (and better sales for you!), so submit applications (along with photo) quickly. It is the sole discretion of the jury board to accept or reject any application.
- 6. Please include a bio of your business and 1-3 photos for social media advertising. Email bio and photo to craftsandcorkscrawl@gmail.com
- 7. Upon completion of being juried by the board, you will be notified ASAP of application acceptance/rejection. If the application is rejected, the board will return your original payment back to you promptly. We will keep your information for the 2025 show, and contact you in case of an opening in your category.
- 8. We ask that you stay for the entire show. Early teardowns (without permission) will result in not being allowed to participate in the future.
- 9. Crafters must keep all displays confined to their 10x10 (or 10x20) space. No infringing on other spaces or walkways.
- 10. We have the right to remove any items that are not family friendly or not handmade.
- 11. Set up time is 9:30. Opening time is 12:00 PM, please be ready for sales by 11:30.
- 12. Crafters are responsible for cleaning up their own display area
- 13. This event is rain or shine.

- 14. You are responsible for your own tent, tables, table coverings to the ground, chairs, display, change, and any other item you may need.
- 15. There is no smoking inside or around the winery. No smoking within craft booth areas.
- 16. No subleasing of your space.
- 17. We ask that there are no pets within vendor booths. Of course, "True" service animals are always welcome.
- 18. Per our liquor license, you are not permitted to bring in your own alcoholic beverages.
- 19. Violation of any rule will result in prompt exit.
- 20. Please unload your vehicle and THEN move to the designated vendor parking area before assembling your entire booth.
- 21. Applications will be juried in rounds approximately May 1, June 1, July 1, and August 1. We will send you an email confirming the receipt of your application and then the
  - application will be juried on the next date. You will be contacted via email after jurying.
- 22. We are working hard to make this an Amazing show. While we spend a lot of money and effort on advertising, it is SO important that EACH of you help!
  - ~ Please HELP! Like and share our FB page and share and interact regularly.
  - ~ Closer to the show, we will be posting pictures of every business and business name ~ if they have been submitted. Share these, so that all your friends can see the variety of amazing items available. With approximately 60 vendors WE can reach a ton of customers together!
  - ~ Hand out Flyers. You can pick up flyers at Grand River Cellars, or download to print.
